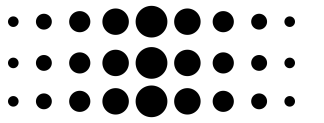

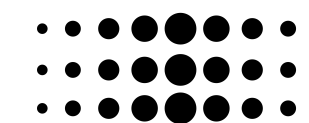


ABOUT US
